A. BACKGROUND

The Whale Tail (Amaruq) satellite deposit is located northwest of the Meadowbank mine and 150 Kilometers north of the hamlet of Bake Lake Nunavut. The project was first licensed by the Nunavut Water Board (NWB) in 2018 following a full environmental review completed by the Nunavut Impact Review Board on March 15, 2018. The project involves the construction, operation, maintenance, reclamation, closure and monitoring of an open pit gold mine.

Following licensing, additional infrastructure to support the Whale Tail and IVR pits were built at the Amaruq site including, truck shop/warehouse, fuel storage and additional camp facilities. In 2018, Agnico Eagle Mines Ltd. (AEM) proposed an expansion project to increase gold production from the original Whale Tail Pit Project by expanding mining activities at the Whale Tail Pit and development of the IVR open pit and underground.

The NWB Water License amendment process for the Whale Tail Pit Expansion Project was completed on 12 May 2020 and Water License Amendment No. 2AM-WTP1830 was issued. Commercial production under the Whale Tail Pit Expansion Project began December 2020.

The current submission by AEM under the Type A Water Licence 2AM-WTP1830 includes the following two documents as required by the Water License 2AM-WTP1830 Part D Item 1 and serve to meet the required 60 days notice prior to construction.

- 2AM-WTP1830 LANDFARM DESIGN MGMT PLAN
- 2AM-WTP1830 LANDFARM DESIGN REPORT

CIRNAC has no concerns with the updated Landfarm Design Management Plans or Design Report provided to the Nunavut Water Board by Agnico Eagle Mines Ltd and offers only the following comment.

C. RESULTS OF REVIEW

1. Responsibilities

Comment:

CIRNAC has reviewed the Landfarm Design Management Plan V2 and the Landfarm Design report provided by AEM and notes that a Summary of Landfarm activities and records to be kept appears in Table 6.2, page 24 of the Design Report.

This table details certain tasks, their frequency and the associated records to be kept related to those tasks however it fail to identify the responsible party for each activity. Additionally, the responsibility for reporting on these activities is also not clearly defined for the reviewer.
