Agnico Eagle Mines Limited (Agnico Eagle or Proponent) has submitted the following:

- Design Report and Drawings for Water Treatment Plant Whale Tail Dike (Design Reports) (Part D, Item 2)
- Whale Tail Dike Design Report (Part D. Item 3)
- Construction Water Treatment Plant Operation and Maintenance Manual (OM Manual) (Part F. Item 12)

as required by Water Licence 2AM-WTP1826 issued by the Board on May 29, 2018. This Licence has not been approved by Minister of Crown-Indigenous Relations and Northern Affairs (Minister) and the Nunavut Water Board (NWB) does not intend to finalize processing of these Design Reports and OM Manual prior to the Minister decision.

However, the NWB notes that Agnico Eagle has very tight timelines regarding the construction of Whale Tail Dike should the Licence be approved by Minister, and makes the Design Reports and OM Manual available for a 15 day public review period. The NWB will appreciate parties' comments submission by July 11, 2018.
