Good morning all,

Please find attached a map of the spill location for the 4m3 grease spill which occurred on Feb.3rd at the Whale Tail Project. I have also included the current action plan for managing this spill on site. Please keep in mind that this is currently a working document and plans may change based on the success of our reclamation efforts.

In response to the disposal of the grease we will NOT be using the MBK landfarm as previously stated. Due to the quantity of grease and a need to mitigating wildlife attraction the grease will be disposed of at the MBK Tailing facility South Cell (see red star on attached map for disposal location)
