Dear Mr. Hanks and Mr. Morrison:

The Nunavut Water Board ("NWB" or "Board") received an application on February 12, 2013 to assign Licence 2BB-BOS1217 from Hope Bay Mining Ltd. to TMAC Resources Inc. pursuant to Section 44 of the *Nunavut Waters and Nunavut Surface Rights Tribunal Act* ("Act").

The Board gave public notice of the application for assignment and invited interested persons to provide comments. Submissions were received from the Kitikmeot Inuit Association (KIA), Aboriginal Affairs and Northern Development Canada (AANDC) and Environment Canada (EC). No adverse environmental effects were identified that would result from the assignment of the Licence to TMAC Resources Inc.

Pursuant to Section 44(1) of the Act, the Board is satisfied that the assignment of operation of the appurtenant undertaking by the prospective Assignee is unlikely to result in a contravention of any condition of the Licence or any provision of the *Act* or the regulations. Therefore, in accordance with Section 44(2) of the *Act*, the Board hereby authorizes the assignment of Water Licence 2BB-BOS1217 from:

the Assignor, Hope Bay Mining Ltd., to

the Assignee, TMAC Resources Inc.

All terms and conditions of this Licence remain in effect. Sections 85 to 94 of the *Act* provide the provisions for the enforcement of this Licence. The Minister of Aboriginal Affairs and Northern Development Canada (AANDC has the power to designate inspectors and/or analysts to identify or determine inspection and compliance related issues. The NWB recommends that TMAC Resources Inc. contact the Inspector for AANDC in Iqaluit to obtain a copy of any enforcement documents related to this licence.

The Board would like to take the opportunity to highlight the following matters that will require immediate action by TMAC Resources Inc.

Enforcement

Aboriginal Affairs and Northern Development Canada (AANDC) carried out two inspections at the Hope Bay Belt, on October 3, 2012 with respect to compliance monitoring and enforcement. Within the October 3, 2012 inspection report, it was noted areas of concerns but correspondence has since been provided that indicates these issues have been addressed, and will be inspected at the next opportunity. In addition, the Inspector indicated that:

While no obvious occurrences of serious non-compliance with the terms of the current Licenses/authorization were identified during the inspection, the inspector remains concerned with the lack of a response to the inspector's requirements.

The Board further advises TMAC Resources Inc. that action is required to rectify non-compliance as identified within the Inspection Report.

Security

In accordance with Part B, Item 2 of the Water License, the Licensee shall furnish and maintain with the Minister, in the form that is satisfactory to the Minister, a security deposit. The existing security deposit required by the Ministry is 1.7 million dollars and is required to be updated. Security is maintained by HBML but existing letters of credit is issued in Miramar Mining Canada's name, the previous Licence holder prior to HBML. Also noted, the beneficiary of the security identifies the Receiver General for Canada and the KIA. Under the purchase agreement HBML Ltd. has agreed to maintain or renew the required security currently required under the Licence holder until TMAC arranges for replacement security. Initially concerns were raised in the technical review regarding the above issues by AANDC, after further dialogue and clarification provided to AANDC by HMBL the above issues have been addressed until TMAC is in a position to provide the required security and to allow the assignment to proceed.

Part B, Item 3 of the Licence required the Licensee to provide the Board, within sixty (60) days following issuance of the Licence, with an updated estimate of the Boston Advanced Exploration Project restoration liability using the current version of RECLAIM, its equivalent or other similar methods approved by the Board, in accordance with principles of INAC's "Mine Site Reclamation Policy for Nunavut" (2000). This updated estimate was submitted by HBML on January 14, 2013.

Annual Report (Part B, Item 6)

The Nunavut Water Board ("NWB" or "Board") has completed a technical review of the 2012 Annual Report for the above mentioned project. The annual report was distributed for information and no comments were received regarding the report at the time of this review. The review found that the report is complete and consistent with the reporting requirements of licence 2BB-BOS1217.

Spill Contingency Plan (Part H)

The Board acknowledges that a revised Spill Contingency Plan (SCP) was submitted by the previous Licensee in October 2012 which addressed the current status of the Project where all activities are being suspended moving into a state of care and maintenance for the Hope Bay Project. The Board has approved the Plan entitled "Hope Bay Mining Ltd. Spill Contingency Plan HB-ER-ENV-MP-001 (REV 5)" dated October 2012, that was submitted by HBML. The Plan fulfills the requirement for the SCP for the NWB Licenses 2AM-DOH0713, 2BB-BOS1217, and 2BE-HOP1222.

The Licensee shall submit to the Board for review within sixty (60) days following issuance of this assignment, an updated Spill Contingency Plan that addresses the change in Licence holder and comments received during the review.

Abandonment and Restoration Plan (Part I)

The Abandonment and Restoration Plan (A&R Plan) (Part I, Item 1) that was submitted by the previous Licensee required revisions to reflect change in management and update the restoration liability estimate. An updated plan has been provided and distributed for comments, with issues being addressed by the Previous Licensee⁵. The Board acknowledged the Plan entitled "Hope Bay Project Boston Camp Revised Interim Closure Plan" dated June 2012 that was submitted as an update to the original plan. In addition, HBML submitted the *December 31, 2012 Hope Bay Project Closure and Reclamation Cost Estimate – Update,* which proposed security in the amount of \$5,988,000. HBML responded to comments received⁶ on February 14, 2013.

The Board has therefore <u>deferred approval of the Plan</u> entitled "Hope Bay Project Boston Camp Revised Interim Closure Plan" dated June 2012 that was submitted by HBML as an update to the original plan. **TMAC Resources Inc. shall submit to the Board for review, within sixty**

(60) days following issuance of this assignment, an updated Abandonment and Restoration Plan that addresses the change in the Licence holder. TMAC Resources Inc., in review and revision of the Plan, shall review/revise and confirm the included Closure Cost Estimate provided by HBML, for the purposes of the Board assessing the security requirements under the *Act*.

Quality Assurance/ Quality Control (Part J)

Part J, Item 15 of the Licence required the Licensee to submit to the Board, within ninety (90) days following issuance of the Licence, a Quality Assurance/Quality Control Plan (QA/QC Plan). The Plan shall include analysis of field blanks and certified reference material, acceptable to an accredited laboratory as required by Part J, Item 16 and replicate sampling in order to assess accuracy, precision and field contamination. The Plan was to be submitted to an analyst for approval; a revised plan has been provided to the Board that covers 2AM-DOH0713, 2BE-HOP1222, and 2BB-BOS1217, and was approved by an analyst on November 27, 2012.

Other Matters

The Licensee is reminded that the Nunavut Impact Review Board's ("NIRB") Screening Decision for File No. EX148, dated May 22, 2012, still applies to the project and can be obtained from ftp://ftp.nirb.ca/.
