"From July 27th to July 29th, the Bionest technician returned on site to clean both Bionests and <u>restart the system</u>. The Bionest technician asked to resume directing black water into the Bionests to rebuild the bacteria flora and initiate the re-starting process. These instructions were confirmed by the Bionest engineer and executed by our team on site. However, we decided to keep three (3) of the eight (8) toilets closed and to use the Pacto toilets instead to reduce the volume of black water send to the Bionest until good performance results are achieved."
