Subject: Hovercraft use at Meadowbank Gold Mine, Nunavut

Thank you for your letter of September 9, 2016. DFO understands Agnico Eagle Mines Ltd. (AEM) is seeking information from Fisheries and Oceans Canada (DFO) as to any requirements prior to initiating the use of hovercraft vehicles in and around the Meadowbank Mine site property.

As you indicate in your letter, AEM is seeking similar advice from other regulatory bodies. DFO agrees that AEM should contact other federal (e.g. Indigenous and Northern Affairs Canada, Environment and Climate Change Canada and Transport Canada) and territorial regulators (e.g. Nunavut Planning Commission, Nunavut Impact Review Board, and Nunavut Water Board) as well as consult with the Kivalliq Inuit Association (KIA).

Specifically, DFO understands that it is the Proponents responsibility under the *Nunavut Project* Planning and Assessment Act (NuPPAA) to submit a project proposal to the Nunavut Planning Commission (Sec.76(1) NuPPAA). DFO cannot make the determination as to whether the operation of the hovercraft constitutes the definition of *project* under the Act.

DFO provides the following questions to AEM:

- 1) Can AEM provide a map of the intended route of the hovercraft to identify which waterbodies will be impacted?
- 2) Can AEM provide a list of mitigation measures to ensure the bed and banks of waterbodies will be protected, as well as ensure the potential mortality of fish and fish eggs is avoided resulting from the noise during the operation of the hovercraft?
