#### **Comments:**

#### A. Background

Agnico Eagle Mines Limited (the Licensee) plans to increase camp capacity at the Amaruq site. In order to continue to meet effluent criteria associated with 2BB-MEA1318 (formerly 2BE-MEA1318) for wastewater as well as accommodate an increased number of people at the camp site, the Licensee plans to install a membrane bioreactor (MBR) wastewater treatment system. The Licensee had originally planned to install two Bionest wastewater treatment systems, but has instead opted for the MBR system. The Licensee has stated that the MBR system will result in better effluent quality than the Bionest systems and will also be able to handle more capacity than the originally proposed design. The Licensee has reported that the installation of the MBR system will allow them to meet the effluent criteria outlined in their current Water Licence.

As per 'Part G: Conditions Applying to Modifications', the Licensee has made a written modification request in order to change the approved wastewater treatment system under 2BB-MEA1318.

### B. Results of review
