Just to update with the 2BB-MEL0914 Licence Renewal/Amendment application status: we are currently awaiting for the NIRB decision to finalize the application for the Board's consideration.

And a couple of small questions:

Amendment 2 to the Licence authorized the Licensee to conduct geotechnical drilling within 31 m of the high water mark along the proposed all-weather road. I may think you don't any more need this condition to be included in the renewal Licence?

Amendment 4 was for the authorization to establish a Non-hazardous landfill. However, based on the AEM reporting and AANDC inspection the landfill has not been built yet. Am I right?
