On August 10, 2007 the Nunavut Impact Review Board (NIRB or Board) received Comaplex Minerals Corporation's (Comaplex) new winter road route project proposal from the Kivalliq Inuit Association (KIA). On August 17, 2007 NIRB received a positive conformity determination (Keewatin Regional Land Use Plan) from the Nunavut Planning Commission (NPC). NIRB has assigned this project proposal file number, 07AN063.

The project is located in the Kivalliq region, and the nearest community is Rankin Inlet.

The project activities include:

 Establishment of a new winter road to the Meliadine West project site from Rankin Inlet, with a proposed term of use per year from late October to late May
