## Dear Ms Gould:

The Nunavut Water Board (NWB) would like to acknowledge the receipt of your letter dated June 9, 2011 and enclosed water use fees for the year 2011, provided for the Meliadine Gold Project, Agnico-Eagle Mines Limited ("the Company" or "AEM"), with respect to Licence No. 2BB-MEL0914.

Upon review of the letter and cheque attached, for water use during the upcoming year, the NWB has determined that the fees provided were incorrect, as calculated according to sec.9 of the Northwest Territories Water Regulations, SOR/93-303 ("Regulations"). In a letter provided by the Board, June 20, 2011<sup>1</sup> to all Licensees paying water use fees (please see attached), direction was provided as to the use of the enclosed "Calculator" and water use fees payable. The fees are to be calculated on an "authorized" basis in accordance with the Licence.

Moving forward, the NWB is returning cheque no. 3732, in the amount of \$60.00 and would like to request that a resubmission of the water use fee, based on the attached information and calculator, be provided for 2011-12 in accordance with sec. 6(b)(ii) of the Regulations, which requires the fees to be paid, in advance on the anniversary date of issuance of the Licence. The NWB has calculated the water use fee to be \$1,058.50 based on a daily rate of 290m<sup>3</sup>/day. Please confirm this prior to re-submitting the payment.
