Dear Ms. Barham:

The Nunavut Water Board ("NWB") would like to acknowledge receipt of the above document under Part H, Item 1 of Licence 2BB-MEL0709 on October 4, 2007. The document was distributed for review and comments with a submission deadline of November 16, 2007, and no major concerns were expressed by the Parties. The document fulfils the requirements outlined in NWB Licence 2BB-MEL0709, and is hereby approved by the NWB under **Motion 2007-52**, dated December 14, 2007.

The Licensee is requested to note that an *addendum* to the approved Plan, to address issues raised by the Parties is required to be prepared within sixty (60) days of the date of this letter.

Issues to be addressed in the *addendum* to the Plan:

- It is noted that the Plan includes product guides that are easy to access and include much of the information contained within MSDS. This is a reminder that MSDS are also to be present;
- In the Initial Spill Response Priorities page, a table including reportable spill quantities is included. It should be updated to include:
 - "all releases of harmful substances, regardless of quantity, are immediately reportable where the release:
 - is near or into a water body;
 - is near or into a designated sensitive environment or sensitive wildlife habitat;
 - poses an imminent threat to human health or safety; or
 - poses an imminent threat to a listed species at risk or its critical habitat;"
- Provide detailed information on all secondary containment berms and fuel bladders. See INAC Comments (available on the Public Registry) for more information;

- Contingency Plans for a large scale spill, for example, contents of a 50,000L tank;
- Update EC 24 hr Emergency pager number on pg 13 to 867-766-3737;
- Update INAC info, to be contacted in event of a spill;
