Hi Jeff,

Thank you for sending the monthly reports. I would ask that you include the information as directed in the 2BBE-MEL1424 report.

"IV. Modify the monthly monitoring reports, starting April 2016, to include, at a minimum, an updates of the construction of the containment structures, waste water treatment options; modifications of the freshet action plan, sampling, and analysis of those results."

This is meant to be a brief update, construction schedules (i.e.: are the berms completed, have you caught water in the trench), water treatment options/ evaporators (i.e.: how long until they arrive), application of freshet action plan (i.e.: steaming culverts, pumping water), has there been any samples taken at P1/ under ice or down stream and analysis.
