### 1. The Licensee shall maintain Monitoring Stations at the following locations:

## 2. The Licensee shall measure and record, in cubic metres, the daily quantities of water utilized for camp, drilling and other purposes from all sources.

3. The Licensee shall measure and record the volume of all soil from all locations entering the Landfarm Treatment Facility.

No contaminated soil was brought to the landfarm in December.

4. The Licensee shall assess and record the concentration of F1 – F4 fractions in petroleum hydrocarbon contaminated soil, according to the CCME Canada-Wide Standard for Petroleum Hydrocarbons (PHC) in Soil that is entering the Land Treatment Unit from all sources and excavations.

No soil samples were taken in December as Agnico Eagle is not planning to take soil out of the landfarm.

5. The Licensee shall provide the GPS coordinates (in decimal degrees) of all locations where wastes associated with camp operations and exploration activities are deposited.

6. Licensee shall sample at Monitoring Program Station MEL-7, monthly during wastewater effluent discharge. Samples shall be analyzed for the parameters listed under Part G Item 11.

Biochemical Oxygen Demand – BOD5 Total Suspended Solids Oil and Grease (and visual) Fecal Coliforms pH

The sample collected on December 5, 2016 exceeded the allowable oil and grease criteria. A spill report will be provided shortly for this exceedance. Agnico Eagle is currently investigating the cause of this exceedance and more information will be provided in the spill follow up report and in the January 2017 Monthly Monitoring Summary Report.

Results collected during the rest of the month were below allowable limits.

- 7. The Licensee shall, prior to the release of effluent from the Bermed Fuel Containment Facilities at Monitoring Program Station Mel-5 and the Landfarm Treatment Facility at Monitoring Program Station MEL-6 for the purpose of demonstrating compliance, sample for the parameters listed under Part D item 15.
  - ➤ In December, no water was released from MEL-5 or MEL-6.
- 8. The Licensee shall obtain representative samples of the water column below any ice where required under part F, Items 5 and 6. Monitoring shall include but not limited to the following:

Total Suspended Solids pH

Electrical Conductivity, and

Total trace Metals as determined by a standard ICP Scan (to include at a minimum, the following elements: Al, Sb, Ba, Be, Cd, Cr, Co, Cu, Fe, Pb, Li, Mn, Mo, Ni, Se, Sn, Sr, Tl, Ti, U, V, Zn), and Trace Arsenic and Mercury.

- No drilling was done in December on any lake.
- B. Modify the monthly monitoring reports, starting April 2016, to include, at a minimum, waste water treatment options; and modifications of the freshet action plan.
  - 1. Waste water treatment options:

In December, no water was transferred from/to the P-cells due to frozen conditions.

- **2. Modifications of the freshet action plan:** An updated version of the Freshet Action Plan will be submitted with the 2016 annual report.
- 3. Seep: There were no active seeps in December due to frozen conditions.

During the 2017 freshet, Agnico Eagle will assess seepage rates at DP1-B and DP3-A as requested by INAC Inspector on November 10, 2016.
