Re: Assignment of Licence NWB2MEL0304

Dear Messrs. Balog and Welborn:

We have reviewed your request to transfer Licence NWB2MEL0304 from WMC Minerals Ltd. ("WMC") to Comaplex Minerals Corp. ("CMC"). This application was deemed to be an application for assignment pursuant to section 44 of the *Nunavut Waters and Nunavut Surface Rights Tribunal Act* ("Act").

Before approving your application, the NWB gave interested parties the opportunity to provide comments within a prescribed period. We received have confirmation from the Kivalliq Inuit Association ("KivIA") that Land Use Permit Nos. KVL302C268, KVLCL102J168, KVRW98F149 and KVL100B195 have been issued to CMC.

In accordance with section 44(2) of the Act, the Nunavut Water Board hereby authorizes the assignment of water license NWB2MEL0304 from WMC to CMC, effective on the date of this letter, which will be placed in the NWB Public Registry.

Provisions for the enforcement of water licences issued by the NWB pursuant to the Act are found in sections 85 to 94 of the same Act, which gives the Minister of Indian and Northern Affairs Canada the power to designate inspectors and analysts responsible for inspection and

compliance. We ask you to contact the Inspector at the INAC District Office in Iqaluit to obtain a copy of any enforcement documents related to this license.
