Hi David,

To summarize our conversation regarding the water license renewal for Mary River, for feasibility study-related activities:

- Renewal of the existing water license to include additional geotechnical information is a simple renewal (not a new license)
- Use the supplementary questionnaire for advanced exploration to accompany the renewal application
- Water take locations do not need to be identified if for one-time use in relatively small quantities (<100 m3/day). This would apply to geotechnical drilling along transportation routes when it is difficult to identify water takes of unnamed watercourses ahead of time and final drill locations may not be confirmed beforehand.
- · On-ice geotechnical drilling at port sites is not covered by NWB see DFO and Environment Canada
- · A multi-year (i.e., 3 to 5 years) renewal can be granted without any additional process
- Bulk sampling program can be addressed by an further amendment to the same license

As mentioned, Rod Cooper forwarded a PDF presentation describing the bulk sampling program to Phyllis' email (<u>licensing@nwb.nunavut.ca</u>) on August 22, 2006. If you are not able to retrieve the presentation from her email, Rod is copied on this email and you can let him know. The presentation will give you an overview of Baffinland's plans and timelines.
