Hello,

QIA will be looking for clarification from the Boards on how to proceed with filing comments in relation to the current application before NWB.

QIA is in the midst of filing two documents:

- 1. A letter directed to NWB in relation to materials filed by the proponent (Call for comments was issued by NWB on January 17th, 2014)
 - a. Note: QIA had previously filed a request for an extension (request submitted on January 30th, 2014) which was later withdrawn on

(retraction request filed on February 6th, 2014). The ability to withdraw the extension request was based upon modifying other organizational priorities related to the project.

A letter directed to NIRB in response to a request for information issued by NIRB on February 7th, 2014.

While QIA can appreciate the prompt response by the proponent (issued on February 11th, 2014) to the items raised by NIRB, is nevertheless QIA is seeking confirmation of the following:

- 1. Does the information filed by the proponent in relation to NIRB letter require any further clarification related to current call form comments being administered by the NWB? (i.e. will the NWB seek the filing of amended documents from the proponent reflecting the change in project activities).
- Does the information filed by the proponent alter the scope or nature of comments NWB is looking to receive from interested parties? (i.e. the NWB going to issue a revised notice for comments to parties?)
- Does NIRB still require parties to file information as request on/before February 21st, 2014?

I appreciate you are all likely considering this information and may need time to respond. Please understand that how the most recent filing of the proponent is treated will influence the content, and possibly timelines, associated with QIA's response.
