RE: Water Licence Inspection - Steensby Inlet Camp July 14, 2009

The following inspection report was generated on a compliance inspection carried out on the Steensby Inlet camp and facilities located at Latitude 70°17'38" N and Longitude 78°29'13" W in the Oikiqtani Region of the Nunavut Territory. The inspection was conducted to determine compliance with the terms and conditions of the Water License (2BB-MRY0710) issued to Baffinland Iron Mines Corp. by the Nunavut Water Board (NWB).

The report references the applicable parts of the Water License (2BB-MRY0710) and the findings observed under each of those Parts. During the writing of this report a compliance review was undertaken of the documents, plans and manuals filed by the Licensee and located on the Nunavut Water Board's FTP site.

The Inspector would like to also thank and acknowledge Mr. Dave McCann, Asst Operations Manager and Jim Mallard, Environmental Superintendent for taking the time to assist and accompany Inspectors during the inspection.

At the time of the Inspection a water license was approved for the project which included the Steensby Inlet Camp. The Licensee issued, is an amended license reflecting an application from the licensee to modify their operations from Exploration to Bulk sampling.

Additionally, other modifications included;

- An application for a Landfill facility
- Submission of a Water Management Plan
- Submission of a Waste Water Management Plan.
- Submission of a revised Spill Contingency Plan.
- Submission of a Fuel Management Plan
- On-going Environmental monitoring

The current License is scheduled to expire on December 31st, 2010.

Issues noted in previous Inspections;

- Fuel was noted as stored on a liner to prevent contamination in the event of a spill. No sidewalls had been constructed and minor tears were noted in liner.
- The area designated as the site for sea-lift fuel barrel storage was noted to be on a slope that terminates at the High Tide mark. The Inspector was concerned that in the event of leak the fuel would run into the Ocean. Properly constructed secondary containment is highly recommended.
- Wastes at incinerator must be properly segregated to prevent Hazardous materials from entering the incinerator.

During the period of the 2009 inspection the following issues were identified by the Inspector;

- o Camp is inactive. No water use or waste being deposited.
- o 7000 barrels of fuel were on site and stored on secondary containment
- Water was noted within the secondary containment

 Fuel storage of this magnitude requires a sufficiently stringent monitoring program to adequately reduce or mitigate the risk to the environment.

A follow up inspection was completed by RMO Robertson during the Demob of fuel from the Steensby Inlet site in September of 2009. – RMO Robertson to produce report on Inspection.
