Baffinland Iron Mines Corporation (Baffinland) is pleased to submit the following documents to the Nunavut Water Board (the Board) in accordance with the requirements of its water license.

Part B, Item 2 - Revised Abandonment and Reclamation Costs Using RECLAIM

Abandonment and reclamation costs have been reviewed and prepared using the latest version of the RECLAIM model (Version 5-1) in accordance with Part B, Item 2 of the water license, and are provided in the attached Knight Piésold Memo Ref. No. NB07-00898, dated October 24, 2007.

A Site Water Management Plan was previously submitted to the Board by Baffinland in accordance with the requirements of its previous water license #2BE-MRY0708 ("Mary River 2007/2008 Exploration Program – Surface Water Management Plan", Knight Piésold Ref. No. NB102-00181/7-3, Rev.0 dated May 17, 2007). We acknowledge that this requirement was carried over as Part B, Item 6 of the current water license.

A revised Site Water Management Plan is attached in accordance with Part B, Item 7 of the water license ("Mary River Project – Site Water Management Plan", Knight Piésold Ref. No. NB102-00181/10-5, Rev.0 dated October 25, 2007). The revised plan builds on the previous plan for exploration activities and incorporates the site activities and environmental protection and monitoring measures associated with the bulk sampling program.

The revised Site Water Management Plan incorporates environmental monitoring so as to meet the requirements of Part I, Item 1 of the water license for an Environmental Monitoring Plan in a single document.



Part I, Item 9 - Quality Assurance / Quality Control (QA/QC) Plan

In accordance with Part I, Item 9 of the water license a Quality Assurance / Quality Control (QA/QC) Plan has been prepared (Knight Piésold Report, "Surface Water Sampling Program – Quality Assurance and Quality Control Plan", Ref. No. NB102-00181/10-7, Rev.0 dated October 25, 2007). The QA/QC Plan forms an appendix of the revised Site Water Management Plan referenced above.

Part D, Item 20 - Bulk Sampling Management Plan

A Bulk Sampling Management Plan is attached in accordance with Part D, Item 20 of the water license (Knight Piésold Memo Ref. No. NB07-00915, dated October 24, 2007).
