Jim,

Finally getting to putting a letter together for your request and need to verify the water use of 15m3 (per day, hour? Indicates a volume, do you have a rate of flow/use?) or maximum of 30m3/hole is not in addition to what is already licensed under 2BB-MRY0710. My understanding is that it is only the water source that you are seeking clarification on and if necessary, an approval. My initial read through and thoughts are that there would be no requirement for additional approval for the water sources based on condition C1 of the licence as amended February 13, 2008 which reads:

Total water use for domestic purposes from all sources shall not exceed a combined total of sixty (60) cubic metres per day. Water for the purposes of drilling and other associated uses, shall be obtained from sources adjacent to drill targets, or as otherwise approved by the Board and is not to exceed four hundred and fifty five (455) cubic metres per day.

If the water volume indicated is in addition to that authorized in the current licence, then an amendment will be required.

Part C, Item 3 which reads:

Streams cannot be used as a water source unless authorized and approved by the Board.

Is intended to prohibit use of smaller streams that would be used as fisheries habitat for spawning/rearing, which could be potentially drawn down by excessive water use. The information provided, seems to indicate that the streams (rivers) in question are substantial and would not be affected by the amount of water proposed to be withdrawn.
