Hello Jim:

Could you please provide the Board with the following information:

1. The scope (Section 2) of the Action Plan states that a containment area will be constructed for the new storage tank and supporting facilities. An explanation is required on what are considered as supporting facilities;
2. Results of geotechnical drilling undertaken in June 2011, aimed at confirming the integrity of the proposed tank location.
1. Confirmation is required on whether the proposed containment dyke schedule for construction this summer (2011) would be confined to that immediately surrounding 5 M litre tank, as depicted in the drawing No. H 337697-4020-042-001. In other words, confirm if the extended containment area projected for future expansion of the fuel storage facility, as shown in the same drawing, will be constructed this summer as well.
2. Alternative method(s), other than land-farming, for the treatment and/or disposal of hydrocarbon contaminated soils affiliated with proposed decommissioning of the existing bulk fuel storage facility at Milne Inlet.
