SNP Sampling

During the month of November 2009, samples were collected at MRY-4 as part of the SNP sampling program. 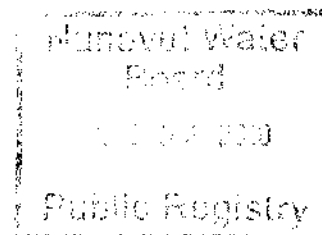
