The attached notice is to amend Water Licence 2BC-BRP1819 security requirements (Part B, Items 2 and 3) such that the Licensee furnish and maintain security with the KitlA rather than the Minister of Crown-Indigenous Relations and Northern Affairs Canada (CIRNAC). Pursuant to Section 43.1.(1) the Nunavut Waters and Nunavut Surface Rights Tribunal Act ("Act"), as the Board gives notice of its intention to consider on its own initiative, the amendment to the 2BC-BRP1819 water licence under subparagraph 43(1)(b)(iii).
