Pursuant to Section 43.1.(1) the Nunavut Waters and Nunavut Surface Rights Tribunal Act ("Act"), as the Board gives notice of its intention to consider on its own initiative, the amendment to the 2BC-BRP1819 water licence under subparagraph 43(1)(b)(iii).
