Hi Tara,

Thank-you for submitting the assignment application document package. Please find some notes from the document review below.

1. The UNDERTAKING OF PROPOSED ASSIGNEE and Affidavit of Execution should be filled out as per the Guide on p. 5 of that document (including completing the affidavit before a notary public)

We read the Guide on page 5 to only require the use of a notary public in the case of an Individual application, whereas this is for a Corporate Entity. Can you please clarify which documents must be notarized?

2. I noticed that the Mineral Exploration Agreement is marked "Confidential" - would WKG like not to have it posted on the public registry? Are there any other pieces in the package that are confidential?

WKG requests that the Mineral Exploration Agreement and its amendments, and the share registers and share certificates for WKG and NRC-X, be kept confidential.

3. Richard advised that the water use fees ought to be paid prior to the Board's decision on the application;

Can you confirm the amount of the outstanding fees?

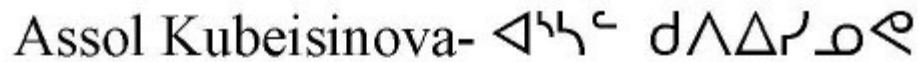
4. The spill plan mentions a different licence number in the text. Inspector contact information should also be added, and the notification schematic should include the Inspector as well (Part H of the Licence provides more detail). In addition, the plan does not address the CIRNA (then INAC) comment on dealing with a large spill (as outlined in the decision and the Licence);

The SCFMP has been updated and will be sent in a separate email due to size constraints. I will supply a blackline version so you can easily see the changes.

5. The A&R plan lists some management plans that we did not receive, i.e. an emergency management plan or a waste management plan. Will Transition/WKG be submitting those?

WKG will comply with the existing emergency management and waste management plans submitted by Transition and approved by the Board. The EMP, ERP and WMP will also be sent in a separate emails due to size constraints.
