Hi Andrew:

The Nunavut Water Board (NWB or Board) has conducted a preliminary review of the above-mentioned application, which the Board received on March 24, 2014.

The review determined that the application is mostly complete; however, before the Board could proceed to the next stage(s) of the licensing process, the NWB requests that the following information be provided at your earliest convenience:

- 1. Anticipated number of drill that to be used and a complete break-down of the total volume of water being requested under the licence amendment. Block 13 of the amendment application, indicates that 98.2 cubic metres/day of water is required for each drill and 2.5 cubic metres/day for camp use.
- 2. Confirmation, as provided by the Nunavut Impact Review Board (NIRB), on whether the screening decision report dated March 22, 2012 would apply to the amendment currently being requested.
- 3. Confirmation, as provided by the Nunavut Planning Commission (NPC), on whether the conformity determination dated April 29, 2008 would apply to the amendment application that is currently before the Board.
