The Nunavut Water Board (NWB or Board) has completed its review of the 2014 Annual Report (Report) submitted by Kivalliq Energy Corporation on February 13, 2015 for the Angilak Project, a uranium exploration project located approximately 225 kilometres southwest of Baker Lake in the Kivalliq region of Nunavut.
