RE: AMENDMENT REQUEST TO MOVE CAMP – 2BE-ANG0813

We are requesting an amendment to our water licence, 2BE-ANG0813, to change the location of the exploration camp. A modest field program, which included an airborne geophysical survey, rock sampling, and the collection for sampling of old core left behind by previous operators of the property, was conducted in 2008. The majority of this field work was based out of the Starfield Ferguson Lake camp. A small camp was established for a short period of time to support the sampling program. The area all around Yat Lake is low lying with significant willow vegetation cover. There are concerns that this area has the potential for high waters during freshet and heavy rainfalls. Following review of photos taken during the field program and maps of the area, two potential locations have been selected that would be more suitable to support an exploration camp.

The two locations are:

- UTM 6937404mN / 526312mE
- UTM 6937672mN / 528031mE

These locations are approximately 1.5 km apart, and are both situated on high, dry sand/gravel and are well back from the normal high water mark of the surrounding water bodies. Photographs of these sites have been included with this request.

As previously stated, a small camp was established briefly in 2008. The camp consisted of seven tents. These tents were taken down at the end of the sampling program and only the wooden floors and frames remain, see the photographs provided. These floors and frames will be moved to the new camp location. A few other items were stored in a boarded enclosure at the camp site over winter; these include an incinerator, water tank, washing machine and dryer. The fuel on site will also be moved to the new location and a fuel cache will be established. Once everything has been moved to the new camp location, a thorough inspection will be conducted to ensure that there has been no damage to tundra. Photographs will be taken of the sites where the tents and fuel were stored. These photographs will be submitted in the annual report to the NWB, INAC, KIA and NIRB.

The Spill Contingency Plan, Abandonment and Reclamation Plan and Wildlife Plan have been updated to include the new proposed camp locations, updated maps and photographs of the proposed

sites. These plans are included with this request. A front page is included in these plans identifying the changes that have been made.
