**RE: ADDITIONAL INFORMATION FOR AMENDMENT REQUEST
KIVALLIQ ENERGY CORPORATION
NWB FILE NO. 2BE-ANG0813**

As follow-up to our initial request that the NWB received on April 20, 2009 to amend Kivalliq Energy's camp location under licence 2BE-ANG0813, included is the final proposed location for our new exploration camp. The location was selected from two possible sites noted in our original request, following some ground truthing this summer and an inspection by INAC Water Resources Officer Andrew Keim.

The new camp is one of the two potential sites previously submitted to the NWB in our amendment request, and a more accurate coordinate for the final new camp location is:

- UTM 6937950mN / 527975mE, NAD83 Zone 14V

As noted earlier, this new site is much more suitable to support an exploration camp since it is situated on high, dry sand/gravel and well back (>100m) from the normal high water mark of a large lake nearby. A map and photographs of this new location are included with this request.

The originally permitted site was utilized for a second season this summer to support a small drill program in August. The camp consisted of seven tents. At the end of the program, these tents were stripped down to wooden floors/frames and equipment put in storage. We intend to move all articles, including 17 drums of fuel remaining, to the new camp location in preparation for resumed operations in 2010. Once everything has been moved to the new site, a thorough inspection and remediation will be carried out at the original site. Photographs will be taken of locations where the tents and fuel were stored, and these will be submitted in the annual report to the NWB, INAC, KIA and NIRB.

For clarity, only a single exploration camp will operate on the property and Kivalliq does not intend to use both the original and new location simultaneously.

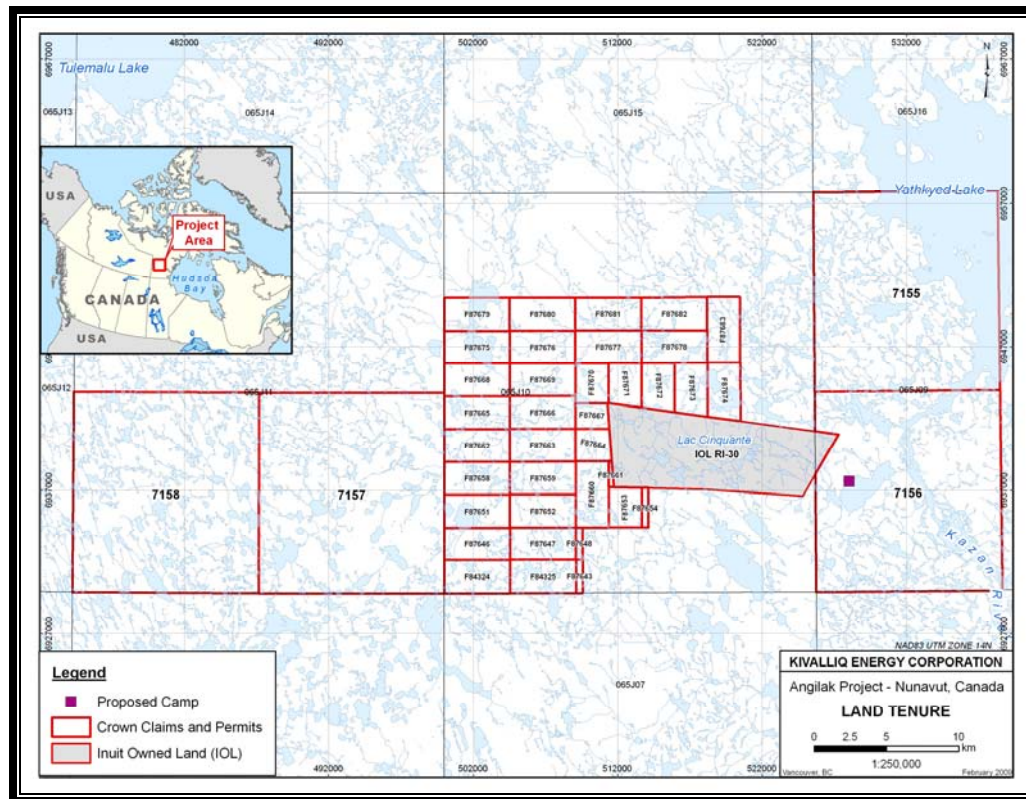

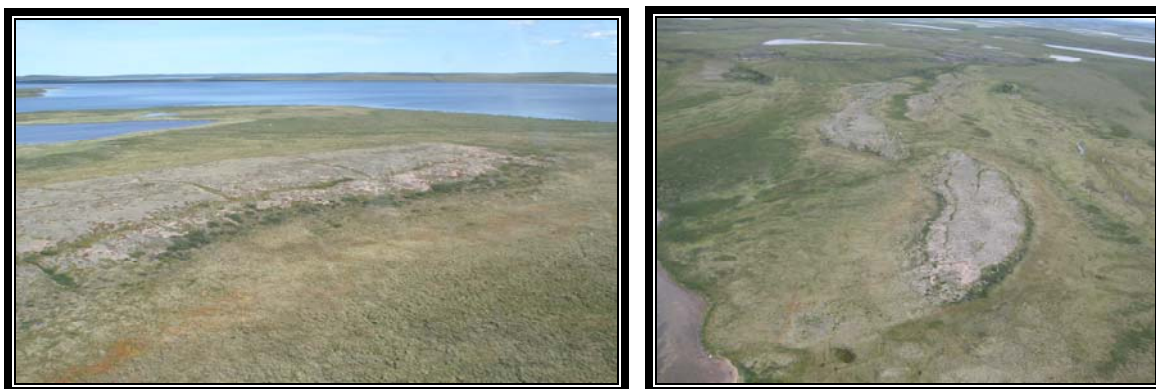
