One quick clarification regarding the NWB Renewal Application for 2BE-ANG1318.

The application does not indicate that sewage will be generated at the camp (Box 14 of the application). However the following is noted in the waste management plan:

### "3.4. Sewage

Pacto toilets are used at the Nutaq Camp. Bags containing black water waste will be incinerated in accordance with the Nunavut Environmental Guidelines for the Burning and Incineration of Solid Wastes. Ash generated from the incineration of Pacto wastes will be sealed in designated 205 L drums and labelled accordingly. Ash drums will be removed from site regularly and transported south for disposal at an authorized facility."

Please confirm that this is correct, i.e. sewage will be incinerated and removed from site.
