**COMMENCEMENT OF FIELD OPERATIONS AT THE ANGILAK PROPERTY**

This letter is to notify Crown-Indigenous Relations and Northern Affairs Canada ("CIRNAC"), the Nunavut Water Board ("NWB"), the Kivalliq Inuit Association ("KIA") and the Workers' Safety and Compensation Commission ("WSCC") that Latitude Uranium Inc. (5833 Nunavut Inc.) will be commencing mineral exploration activities at the Angilak Project.

The planned exploration work for 2024 will be undertaken in two separate field programs. The 2024 spring program is anticipated to be 4 weeks in duration and with mobilization to commence on March 4, 2024. The spring program will include mobilization of fuel and supplies to Nutaaq camp.

The 2024 summer program is anticipated to be completed between early June to mid-September and will comprise diamond drilling, mapping and rock sampling. Both programs will include continued environmental baseline sampling and monitoring. Another Letter of Commencement will be submitted prior to the summer program.

All operations conducted will adhere to conditions specified in the CIRNAC Land Use Permit ("LUP") N2019C0013, NWB Water Licence 2BE-ANG2227 and KIA land use licence KVL308C09.
