Kivalliq Energy Corporation's YAT Camp site (98 59' 32"W Long., 62 32' 40"N Lat.) was used to support field operations in 2008 and 2009. In April 2010, Kivalliq established the Nutaaq camp in a location proximal to our advanced exploration activities at the Lac Cinquante uranium deposit.

Kivalliq has been performing reclamation at the YAT site over the summer 2010 field season. Over the Labor Day weekend, I had crews at the site disassembling and salvaging lumber from the tent frames that comprised the camp facilities. This material has been removed from site and will be used at the Nutaaq camp.

As a final part of the reclamation operation I am seeking authorization to conduct a controlled open burn of clean wood materials that remain on site. The fire contemplated will be confined to an area of approximately 10m<sup>2</sup>, less than the foot print of a single tent frame. As a final part of the reclamation

exercise ashes from the fire will be collected in sealed 45 gallon drums and removed from the location.

I have consulted Jeff Mercer with INAC regarding burn restrictions under Land Use Permit #2008C0026. Open burns are not specifically prohibited by our licence. I am seeking NWB's approval under Licence No. 2BE-ANG0813 to proceed with a controlled burn of remaining wood debris so that we may continue with our reclamation efforts.
