Project Summary:

North Arrow Minerals Inc. operates the Anialik River Project. The company is undertaking mineral exploration activity to determine the extent of gold, base metals, and diamond deposits in an area located approximately 180 km southeast of Kugluktuk. North Arrow is proposing to carry out early-stage exploration work for the Anialik River Project including prospecting, geological mapping, sampling and ground geophysics. Depending on the results of this activity, a diamond drilling program may be initiated.

North Arrow Minerals Inc. submitted the application for renewal to the Nunavut Water Board on July 16, 2008.

As a result of my review of the renewal documents regarding this project, the following is provided for consideration in the water license approval process:

1) Spill Contingency Plan

North Arrow Minerals should update and resubmit their spill contingency plan to the Nunavut Water Board and include the following;

- Identification of all camps and fuel storage areas as soon as determined by the proponent
- A list of the contents of the spill kits
- List of the amounts and types of fuel / chemicals to be stored on site as soon as determined by the proponent
- MSDS sheets for all fuels and chemicals should be attached to the spill plan
- As per the existing licence, 2BE-ANI0608, Part G, 1. viii., the Licensee should include a site map of sufficiently large scale to show the location of buildings, contaminants storage areas, sensitive areas such as water bodies, probable pathways of contaminant flow and general topography

2) Existing Terms and Conditions

It is noted that the existing terms and conditions listed in water license # 2BE-ANI0608 are sufficient for water use and waste disposal activities proposed by North Arrow Minerals for the Anialik River Project (July 16, 2008 application to the Nunavut Water Board).
