We undertook a preliminary review of your application and conclude that it meets the requirements of section 48(1) of the *Nunavut Waters and Nunavut Surface Rights Tribunal Act* ("Act"). This said, I must inform you that the NWB reserves the right to request additional information and studies pursuant to sections 48(2) of the Act or, alternatively, issue guidelines for the provision of information pursuant to section 48(3) of the Act.

The NWB Technical Advisor assigned to your application may be in touch with you to clarify any technical details related to your application.

Pursuant to Section 13.7.3 of the Nunavut Land Claims Agreement this application is of a class that does not require a public hearing, and is therefore exempt from screening by the Nunavut Impact Review Board, as per Schedule 12-1 of the NLCA.

The Board will not act on the application as required by Section 55(4) of the Act, however; to facilitate the administrative processing of the application the Board requests comments from the regulatory agencies by April 3, 2008.

Finally, by copy of this letter & notice to the municipal distribution list most affected by your application we invite interested persons of the municipalities to make representations. Please note that a Spill Plan & an Abandonment & Restoration Plan was also received with the application and requires review. The NWB may provide additional procedural instructions once the application has been reviewed.
