Hello Phyllis

Thank you for your email on Monday of this week and your efforts to cancel the water licence.

Today Stornoway and Vaaldiam received a Water Licence Inspection Report on 2BE-ASH0611 from Eva Paul documenting a visit to two drill sites on September 16th 2013. These sites were selected from a list of seven drill sites covered in a 2005 annual report for 2BE-ASH0305. One of the drill sites had a piece of drill steel and two small pieces of wood. Ms Paul has required reclamation to be "conducted and proven" by Sept 30, 2014 through submission of a report and photographs for all seven sites. Unfortunately, given the two month delay in receipt of this information and the current weather conditions we are obviously unable to complete this work in 2013.

The camp sites covered by licence 2BE-ASH0611 have been previously inspected and approved for closure. Ms Paul's report accepts these previous inspections.

Given the requirement to revisit the seven drill sites in 2014, is it still possible to proceed with cancelling the water licence now or will we have to wait until 2014?

We appreciate your comments (and I miss Nicole).

2. September 26, 2013, request to Vaaldiam to provide authorization for Stornoway to act on their behalf.

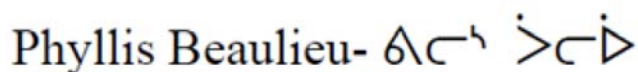
