Thank you for forwarding me the guidelines for on ice drilling.

As summer draws closer I am in the process of planning our exploration activities for 2003, and getting all the permits in order before we head out. Last year was our first year and I applied for a license and it was awarded (NWB2BAF0204). On the original application I checked the box advanced exploration, which was what I thought at the time the closest to what we where up to. We were undertaking a sampling and mapping program. As you can see below, Rita Becker correctly changed the type of undertaking from advanced exploration to exploratory drilling. I later found out that advanced exploration entailed the collection of a bulk sample. As we did not fit in any exact category the exploratory drilling thus seemed the closest fit. The exact undertaking was expanded upon in the application in the appendices 3 and 4

This year our project will be the same as last year, geological sampling and mapping but we will also have an exploratory drill program as well. I therefore hoped that our existing permit which expires

September 1 2004 might still be valid
