Sorry for the delay in replying. I was out visiting some of the communities were will be working from and was out of contact for a week or so.

My initial note to you was regarding or water usage summary as outlined in Part B general conditions. This you needed by March 31st.

One of my requests was that on the permit or camp locality is stated as

South of Grifford Fiord, Baffin Region, Nunavut, general camp latitude 70 24' W; longitude 80 39' W. NTS Map 47E 1:250,000.

I see there was a typo with the latitude having the suffix W instead of N. The other request was giving the exact camp locality of Latitude 70 37' 29.5" North and 80 4' 16.5" west.

I was hoping that these corrections could be made and the same licence re-issued, but was informed that I would have to go through the whole re-application process just to correct a typo. As our licence is still valid until September 1st 2004 (the end of our field season) I thought I would do the re-application next year.

I see from your note you refer to an amendment. This is new to me, I thought I had to go through the whole process of submitting the applications forms, maps and supporting documents, translations, getting an ad placed etc.

I can't recall to whom I spoke on the phone but mentioned that I would not go through this process as the typo was small and not worth the

effort to correct. We will be reapplying for a new licence next year and the changes can be reflected in the new permit then.

Quite a long story just for a small change.
