Mr. Lunn,

I have reviewed a copy of the issued water license (2BE-BAF0611)(enclosed), the submitted A&R plan (Submitted on January 26th, 2009 by Pure Diamonds Exploration inc)(enclosed) and your original emails.

In review of the above I would like to ensure you are aware of the following;

The submitted A&R plan states as follows;

- 1. Grey water Sumps will be monitored and if required will be back filled and re-contoured.
- 2. All remaining garbage will be incinerated in an incinerator.
- 3. All wood (tent floors, frames etc.) will be removed from the site to an approved landfill site or will be burned along with all other combustible material in an incinerator or equivalent. Any excess refuse will be removed from site.
- 4. All camp materials, fuel drums, and drilling equipment will be removed from the site.
- 5. All drilling sumps will be backfilled, burying the unused cutting and drill waters.
- 6. Each drill site will be inspected prior to departure to make sure all garbage has been removed and any disturbed ground will be reclaimed.

The License (2be-BAF0611) assigned to Pure Diamond Exploration Inc ( now known under the name of Burnstone Ventures) outlines the following;

## PART D: CONDITIONS APPLYING TO WASTE DISPOSAL

- 2. No open burning or on-site land filling of domestic waste is permitted.
- 3. The Licensee is authorized to incinerate all food waste, paper waste and wood products, and shall ensure that all hazardous wastes, waste oil and non-combustible waste generated through the course of the operation are backhauled and disposed of in an approved waste disposal site.

And;

## PART H: CONDITIONS APPLYING TO ABANDONMENT AND RESTORATION

- 1. The Licensee shall complete all restoration work prior to the expiry of this Licence.
- 4. The Licensee shall remove from the site infrastructures and site material, including but not limited to, all fuel caches, drums, barrels, buildings and contents, docks, water pumps and lines, material and equipment before the expiry of this License.
- 9. Drill holes shall be restored to natural conditions immediately upon completion of the drilling.

As outlined in the above, If the Licensee intends to close the camp permanently all infrastructure associated with the project is to be removed from the site and the area returned to as close to natural conditions as possible.

I have spoken with Kevin Robertson, our Lands Inspector and it is his intention to inspect the site, if possible this year. If this proves to be impossible he will be attending the site as early in the field season of 2011/12 as possible to ensure the project has been completed as required.

At this time I see no reason for you not to proceed as outlines so long as the above conditions are adhered to.

I look forward to reviewing your final report on closure and I wish you the best of luck during the remainder of this project.

Please ensure the Nunavut Water Board and Mr. Kevin Robertson are cc'd on all future correspondence with respect to this file.

Kris Raffle has asked me to get in touch with you in regards to the site remediation of Burnstone's Erickson Lake Camp on Baffin Island.

I have some people digging up all of the contaminated soil on site. The airstrip at the camp has been heavily damaged from washouts over the past couple of years and is unusable. Our current plans, if acceptable to you, is to dig up all of the contaminated soil into sealable drums and leave on site until the snow flies this winter. At which point, we would come in with a Twin Otter on skis and haul the soil and remaining fuel drums from site to Igloolik for transportation south. It is likely, at the same time, that we would remove the camp in its entirety to Igloolik.

Last year the landuse inspectors noted a small fuel spill from a leaking drums on the esker strip and some garbage that needed cleaning up around camp. Burnstone had to commit to cleanup this year but they don't want to do an exploration program to coincide. Hence the short mission.
