Good morning Gordon,

I have reviewed your file and provide the following in order to cancel/close the file.

There is an outstanding water use fee of \$584.00 owing for June 16, 2013 to the end of the licence. This will be required prior to closing the file. Water Use Fees are payable for the authority to use water, not the actual amount used.

The term of your licence is June 16, 2011 to June 16, 2014. There is an annual report on file for 2014 but none appear for 2014 (from April 1, 2014 to expiry, June 16, 2014). You have indicated there was no activity on site for 2014 and therefore no annual report for 2014 is required. There are no other administration issues outstanding.

Note that a final inspection by AANDC is required to completely close of this file.
