Hello Mr. Kottmeier,

Your projects have been off my radar for awhile, but came across reference to Bama Gold Corp online this morning. A glance over the Nunavut Water Board FTP site shows that no submissions have been received in respect of the above projects. These licences are now both expired, however, by virtue of s.46 of the *Nunavut Waters and Nunavut Surface Rights Tribunal Act*: "The expiry or cancellation of a licence does not relieve the holder from any obligations imposed by the licence."

You have had ample time to produce the documentation and reports required by these licences. Please review our earlier correspondence, the water licences in question, and submit the outstanding documentation to the Nunavut Water Board at the above address.

Annual reports are to be filed for every year of the licence, whether or not any work was carried out. Up-to-date company information (company name, changes to contact person etc.) is also to be provided.

These documents are required by March 31, 2016.

Reports on these projects have never been filed with AANDC. The projects are both on Inuit Owned Land, and as such your land authorizations would be issued by the Kitikmeot Inuit Association. In this situation, AANDC is only involved at the inspection stage, as inspectors of the Water Licences issued by the Nunavut Water Board. As the required documents have never been filed with the NWB, there are no records to which I have access.

It will be your responsibility to obtain the required records from your ex-VP and to continue with the process of assigning the licences to the appropriate parties (name change) as previously discussed.
