**Subject: Assignment of License 2BE-BRO0607 (previously NWB2BRO0607 (Type B))**

Dear Ms. Stritychuk and Ms. Ball:

The Nunavut Water Board (“NWB” or “Board”) would like to acknowledge the receipt of an application on April 16, 2007 to transfer License 2BE-BRO0607 (previously NWB2BRO0607) from Kennecott Canada Exploration Inc. to Diamondex Resources Ltd. This application was deemed to be an application for assignment pursuant to Section 44 of the *Nunavut Waters and Nunavut Surface Rights Tribunal Act* (“Act”).

The Board gave public notice of this application for assignment and invited interested persons to provide comments. Although submissions were received, there were no adverse environmental effects identified that would result from the assignment of the License to Diamondex Resources Ltd.

The Board is satisfied that the operation of the appurtenant undertaking by the prospective assignee will not be likely to result in a contravention of any condition of the License or any provision of the *Act* or the regulations. Therefore, in accordance with Section 44(2) of the *Act*, the **Board hereby authorizes the assignment of water license 2BE-BRO0607 from:**

**the Assignor, Kennecott Canada Exploration Inc., to**

**the Assignee, Diamondex Resources Ltd.,**

(**Motion #2007-14**) effective on the date of this letter, which will be placed in the NWB Public Registry.

The Licensee shall ensure any document(s) or correspondence submitted by the Licensee to the Board is received and acknowledged by the Manager of Licensing.

**Part F, Item 6**

Where drilling activity has penetrated below the permafrost, the NWB requests that the proponent record the depth of permafrost and location of the drill hole to be included within the Annual Report.

**Spill Contingency Plan (License 2BE-BRO0607, Part H)**

A Spill Contingency Plan was submitted by the previous Licensee and approved by the Board. As this assignment will likely involve changes in operations, personnel and site facilities, the current Spill Contingency Plan shall be reviewed and updated.

**The Board hereby notifies Diamondex Resources Ltd that it shall submit to the Board for approval, within two (2) months of the effective date of this assignment, a revised Spill Contingency Plan.**

**Abandonment and Restoration Plan (License 2BE-BRO0607, Part I)**

An Abandonment and Restoration Plan was submitted by the previous Licensee and approved by the Board. As this assignment may involve changes in operations and the planned abandonment and reclamation activities, the current Abandonment and Restoration Plan shall be reviewed and updated.

**The Board hereby notifies Diamondex Resources Ltd that it shall submit to the Board for**

**approval, within two (2) months of the effective date of this assignment, a revised Abandonment and Restoration Plan.**

**Enforcement**

Effective upon the date of this letter, **License 2BE-BRO0607 is assigned to Diamondex Resources Ltd. and all terms and conditions of this License remain in effect.** Sections 85 to 94 of the *Act* provide the provisions for the enforcement of this water License assigned by the NWB. The Minister of Indian and Northern Affairs Canada has the power to designate inspectors and analysts responsible for inspection and compliance. The NWB asks that you contact the Inspector at the INAC District Office in Iqaluit to obtain a copy of any enforcement documents related to this License.
