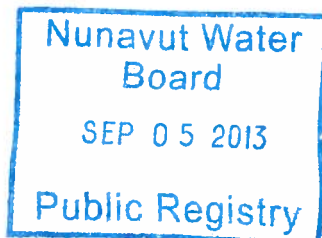

***This license expired on September 30, 2008. Abandonment and reclamation activities on the land use area have been completed.***

**8. ABANDONMENT MEASURES**

***Land use for the project was conducted under the authority of INAC Land Use Permit N2004C0008. On July 26, 2010 the Resource Management Officer for the Kitikmeot Region conducted a final inspection of the land use area and a letter was issued by INAC on November 18, 2010 granting final clearance and closure for the permit. A copy of the inspection report and closure letter was submitted to the Nunavut Water Board on June 24, 2013.***
