I called the spill line as the spill didn't show up in my search. It was reported, and the spill report is attached. Looks like it was at the main camp. When you go in (snow free period) you'll have to do a visual check to determine if there is anything left. If it occurred in the winter it may never have contacted the soil. And... it might have been on the ice, depending on the accuracy of the coordinate...

Hi Mike,

Any questions while I'm away can be referred to my Manager, Erik Allain. He's copied on this message.

I have not planned my inspections for the 2014 field season. Our inspection priorities are determined first based on risk, and then we look at what low-risk sites we can fit in on our path. I think the only one I haven't inspected in the past 2 years is 2BE-NTI0507 (Strongbow) but I do have some notes I took in 2012 that I need to review. With respect to final inspections, on a file-specific basis I may determine that re-inspection is not necessary if the clean-up reports are sufficiently detailed and photographed.

What I can say is that I will be doing a review of all the known licences in the Kitikmeot Region this spring to determine whether there are outstanding requirements. Feel free to try and get ahead of me on this. :-) Please copy me on any submissions to the NWB, as sometimes they get back-logged and it can be awhile before submissions are posted to the Public Registry. For licences in the Kivalliq Region (eg - 2BE-WLS0406 (Strongbow)), correspondence can be copied to Christine Wilson (christine.wilson@aadnc-aadnc.gc.ca).

As we discussed, I'm still around tomorrow afternoon if you have further specific questions.
