## WATER USE INSPECTION REPORT

The coordinates approved in the water licence are indicated as N67° 59' 34", W111° 07' 00", which are inaccurate.

The coordinates provided in the Final Plan Report submitted by Mr. David Gale of Strongbow Exploration (dated August 1, 2008) cites the 2006 camp location as N67° 27' 56", W111° 07' 56" (and is also referenced as such in the 2006 and 2007 Annual Reports), but according to the maps provided in the Final Report Plan appears to be located in the same area as the "historical" camp location at N67° 07' 55", W111° 08' 01" (which is the site inspected in 2010).

Therefore inspection findings at the Canoe Lake camp location (NAD 83, degrees/minutes/seconds): N67° 07' 55", W111° 08' 01" are the following:

- Large pieces of woody debris (some large charred pieces) and plywood; stakes with flagging tape and a wooden sign post (possibly used as a warning marker for well casing)
- 2 burn barrels found in a water-filled depression
- Possible historical debris: core boxes in disarray; drill casing extending out of gossan deposit
- Fuel cache of 5 full drums (4 Jet-A, 1 Jet-B) was located at N67° 07' 57", W111° 07' 05", labelled with a fill date of March 2005, and "TMX", "AGL-TEMEX" on the side.

## Issues/Non-Compliance of Act or Licence:

Before this licence can be considered for closure, the Licensee (or the Licensee's representative) must provide clarification as to the actual camp location and any documentation, such as photographs, which would indicate which wastes on site are historical.

As well, wastes left on site (such as woody debris and wastes) are still the responsibility of the Licensee and a plan for removal with dates is to be submitted to the Inspector.

The Licensee is to confirm whether the fuel cache identified near the site belongs to them or was associated with their project. Any further information that can be provided regarding this fuel would be appreciated.
