Good Morning Tara,

- Please revise the Abandonment and Restoration Plan, Committee Bay Property, 1. Nunavut, Canada, dated June 1, 2017 to include topography maps, site location details for the fuel and proposed camp locations.
  - The exact locations of the camp site and Fuel caches for the Committee Bay Project have not yet been determined. In the past, water licences have been granted without the exact locations supplied, with the understanding that all relevant agencies will be notified of them as soon as they are determined. An example of such an authorization is the 5530 Nunavut Inc. Meadowbank Project 2BE-MPM1722. We would like to request that this licence be granted in the same manner, with the condition that the locations be supplied prior to mobilization.
  - All the Project Management Plans will be updated (including the figures) with the locations of camp, fuel caches and drill holes as soon as they are determined and will be submitted to all the relevant agencies.
- Please revise the Spill Prevention and Response Plan, Committee Bay Property, Nunavut, Canada, dated June 1, 2017 to include ECCC's contact number, a topography map with the proposed location of the camp, related water bodies, fuel cache location, and the spill kit locations. Finally please revise the embedded Spill Report Form and Guide to be electronic versions of the files, as opposed to an image, so as to allow the users of the Spill Plan to be able to edit the info directly.
  - During the NIRB review of this Project the ECCC requested that their number be removed from the Spill Prevention and Response Plan (see comment attached).
  - All the Project Management Plans (including the Spill Prevention and Response Plan) will be updated (including the figures) with the locations of camp, fuel caches, drill holes, spill kits and any related water bodies as soon as they are determined and will be submitted to all the relevant agencies.
  - The Spill Report Form included in the Spill Prevention and Response Plan is included as a guide and is not the actual form that will be used. All personnel on the Project will have access to the digital editable version of the form.
