# 1 Project Location and Description




Figure 1.1. Committee Bay Project Location

The Committee Bay Project (the "Project") straddles the border between the Kivalliq and Kitikmeot Regions in eastern Nunavut. The Property is located within the 1:50,000 scale National Topographic System ("NTS") map sheets 56J (Walker Lake) and 56K (Laughland Lake). The Project consists of three non-contiguous claim blocks (Block A, B and C) located on Crown Lands, approximately 300 km west of the community of Repulse Bay (Naujaat), 300 km northeast of the community of Baker Lake (Qamani'tuaq) and 400 km northwest of the community of Rankin Inlet (Kangiqliniq; Figure 1.1).

The mineral claims are all 100% owned by 5530 Nunavut Inc, a wholly owned subsidiary of Western Atlas Resources Inc.

## 2 Land and Water Use Authorizations

All land and water use authorizations are in the name of 5530 Nunavut Inc.

There was no exploration completed on the Committee Bay Project in 2019.
