Greetings, Brian,

Between this summer and autumn 2012, Peregrine will be seeking new authorisations to work on its existing 3 exploration properties in the South Baffin – Chidliak Project (Hall Peninsula), Qilaq Project (adjoining the Chidliak Project on the Hall Peninsula) and the Cumberland Project (on the Cumberland Peninsula.) Because we last communicated on this subject in March 2011, I have attached here a map slide which depicts the South Baffin locations of the properties.

Chidliak Project - #N2008C0005 (Land-Use Permit) and #2BE-CHIOB13 (Water Licence):
