As requested, please find below our comments on the 2013 Annual Report that was submitted by Peregrine Diamonds Ltd. (PGD):

1. There were two reported incidents of 'small amounts of hydraulic oil' leaks from the same air compressor. It was not clear from the incident reports whether that air compressor was suitable for (extreme) cold weather operation, i.e., due to a pressure release valve that was subject to malfunction (in cold weather).

Questions: Can that air compressor be replaced with an alternative equipment, i.e., one that is better suited for (extreme) cold weather operation, or less affected by a malfunctioning pressure release valve? Can that pressure release valve on the current air compressor equipment be replaced by a valve that is better suited for (extreme) cold weather operation?

2. <u>Question</u>: With respect to the diesel fuel spill (8 L from one drum) at the CH-6 camp (Chidliak Property), what controls (administrative or engineered) are in place to prevent such similar incidents in the future?
