There are two points that require further clarification:

1) BOX: "Results of the monitoring reports"(page 3)

It states "CH6 Trench water monitoring - Report submitted separately" I have attached the report as a *.pdf.

The Trench Water Monitoring Report can't be found in 2BE-CHI1218 folder at the NWB Public Registry. I am quite certain it was sent to them but I realize the amount of paper work they deal with is almost insurmountable as is their workload. Anyways it is attached.

Please, could you submit it

2) BOX "A summary report of water use and waste disposal activities, including but not limited to: methods of obtaining water, sewage and greywater management, drill waste management, solid and hazardous waste management." (page 1)

It states "bulk metals etc to landfill" My mistake and omission it should have said Iqaluit landfill metal depot... my terminology may be off a little here....the place in Iqaluit designated for scrap metal

On-site landfilling is not authorized under the Water Licence (Part D, Item 2). Please, could you clarify whether there is a landfill at site? There is no landfill at site. All bulky debris is .
