Greetings, Don,

You'll note by the attached (as well as the recent CBC Radio announcements), that Peregrine has discovered 2 kimberlite outcrops on its Chidliak Property, Baffin. The applicable NWB licence is: #2BE-CHI0813. The new Peregrine land-use permit (#N2008C0005) permits drilling, and Peregrine would like to speed up its original project drilling timetable, by doing a short programme of test holes -- I expect, before the end of this season (i.e., soon). I would expect they'd want to sample both outcrops, but I have asked for a map. It makes sense to test the anomalies now, so that data can be fed into planning for 2009.

Whilst I await details from Peregrine, I wanted to get your initial reaction to, and possible support for, this request; I have sent a similar note to Jeff Holwell of INAC. The rig used would be the little waterless heliportable RC rig that Indicator is using at Nanuq North (information already supplied). Therefore, this small programme would not require any use of water.
