Dear Phyllis:

The following answers your question:

- 1. We are planning a very small exploration program in 2014 which should take place over a 3-4 week period. Upon completion of the program, the camp will be dismantled and all gear and equipment will be flown out and stored either in Kugluktuk or Yellowknife. All tents, tent frames and floors, camp supplies, equipment, empty barrels etc. will be flown out to storage. There will be nothing left at the site. Any pits dug will be filled in. All garbage will be burned and the non-combustable material will be flown out to Kugluktuk to be disposed of appropriately in Kugluktuk.
- 2. I have contacted our accountant to request the most recent financials and they will be forthcoming as soon as I receive them, likely later today. These will not be audited. We are a very small, private company and as such do not have the regulatory requirement to have audited financials. Audits are very costly and are not necessary for companies at this stage of development. We expect to become a publicly trading company on the TSX Exchange in the near future at which points audits will be required. We are in the midst of a financing campaign, the proceeds of which are necessary before we can proceed with our field program. We expect that to be completed within the next two weeks.
- 3. Coordinates for our proposed camp location are provided in section 9 of the remote camp questionnaire send to you as part of our application. I have included in this email two maps with a 'pdf sticky note' pointing to our first and second choice camp locations. Since submitting the application, the first and second choice locations have been reversed. Our first choice now on mineral claim RML 28 and is closer to the area of most of our planned work. There is no existing infrastructure in the area of our first choice. The second choice is located at the south end of the Hope Lake airstrip shown on the map.

Additional Information subsequent to submitting our application:

- 1. In our permit application, section 8, I checked the box that indicated a Nunavut Impact Review Board screening would be required. I have since received an email stating that a NIRB screening will not be required at this point.
- 2. The cheque for the application fees that I scanned and emailed was couriered to your office some time ago. If it has not yet been received, please let me know and I will track it down. As indicated in a subsequent email from you, I will have a cheque for the remaining fees in the amount of \$156.15 couriered to you immediately.
